

HPNA BROCHURE LICENSE AGREEMENT

The following terms and conditions govern access, downloading, printing, posting, distribution and all other use of the Hospice & Palliative Nurses Association ("HPNA") position statements, resources, resource guides, educational materials, brochures, and all content and information provided therein (collectively, the "Brochures"). By accepting the terms of this License Agreement in the space indicated below, you acknowledge that you have read, understood and agreed to be bound by this License Agreement, you agree to comply with all applicable laws and regulations and you represent that you are authorized to enter into this License Agreement on behalf of yourself, your employer or other user of the Brochures (as applicable). ***If you do not agree to these terms and conditions, you may not access, browse, print, download, post, distribute or otherwise use the Brochures in any manner.*** The Brochures are protected by law, including, but not limited to, United States copyright law and international treaties. If you fail to comply in any way with these terms and conditions, your authorization to access, browse, print, download, post, distribute or otherwise use the Brochures will automatically terminate and HPNA will pursue all available legal remedies.

Authorized Use & Restrictions:

5. You may not alter the Brochure in any manner or remove any of the notices contained therein. Specifically, you may not delete or obscure HPNA's name or trademark notices.

Except for the Authorized Use specified above, you may not copy, modify or distribute any of the Brochures. Permissions. If you wish to use the Brochures in any manner not expressly permitted by this License Agreement, you may request permission from HPNA by giving to HPNA a written description of the intended use and such other information as HPNA may request. Only an authorized representative of HPNA may grant such permission.

Trademarks. The trademarks, service marks, trade names, tag lines and logos (collectively, the “Trademarks”) used and displayed on the Brochures are registered and unregistered trademarks, service marks and/or trade dress of HPNA or its licensors, and you may not copy, imitate or use the Trademarks, in whole or in part, for any purpose, including without limitation in any marketing or advertising materials. Term and Termination.
